### 收集個人資料聲明

#### 私隱權政策及免責聲明

無障礙城市定向 秘書處 (秘書處) 尊重閣下的私隱權, 並承諾保障閣下向我們提供的個人資料。我們會遵循並按個人資料 (私隱) 條例 (香港法例第 486 章) 的規定收集、保存、處理及使用閣下的個人資料。

#### 私隱權政策

- ◎ 秘書處在閣下登記成為「無障礙城市定向 2018」義工, 秘書處將收集、儲存及使用閣下的個人識別資料 (包括: 姓名、身分證號碼 / 護照號碼、電郵地址、出生日期、性別、電話號碼、傳真號碼、地址及活動期間進行拍攝活動等。)
- ◎ 秘書處收集、儲存及使用閣下的個人資料作以下用途: 提供適合閣下的活動、計劃、課程、班組或義工服務、提高我們的服務質素、與閣下聯繫及用作研究等。
- ◎ 在拍攝活動所得的所有資料 (如: 相片、影片等), 秘書處可以在未再通知 / 未經過當時人同意之下進行修飾, 並將當時人之肖像在各媒體 (包括: 電影、電視、廣播、電台、印刷品 [如: 書籍、雜誌、報紙等]、電腦媒體 [如: 網站、臉書(Facebook)、電腦程式、手機程式等]) 發佈。
- ◎ 秘書處亦可進一步使用有關個人資料和 / 或提供該等個人資料給其他機構 (包括代理人、承辦商, 或提供行政、電訊和電腦系統服務予「香港傷健協會」(HKPHAB)、「傷健義工數碼坊」(ITV) 及 蟻工 有關業務的第三方服務供應商), 用作直接促銷, 以及任何與 HKPHAB、ITV 及 蟻工 活動推廣有關之代理商、贊助商、任何獲授權的人士、公司和組織的推廣用途, 但除非收到閣下的書面同意, 否則秘書處不會使用或提供有關個人資料。

#### 資料保安

個人資料的保安當秘書處接收到閣下的個人資料時, 秘書處會即時保存妥當並予以保密, 只有得到授權及相關工作人員才可獲准接觸有關資料。秘書處亦會確保工作人員遵從在個人資料保安及保密方面的操守。如閣下使用網上登記方法, 當閣下每次透過網上傳送個人資料時, 本處將不能確保百分之百的保安保障。

- ◎ 根據《私隱條例》的條款, 我們有權就處理任何資料查閱要求收取合理費用。如閣下要求查閱個人資料, 我們可能需要採取措施來驗證閣下的身份。閣下可透過以下途徑 (本頁底部) 與秘書處聯絡。

### Personal Information Collection Statement

#### Privacy Policy and Disclaimer (PPD)

The Secretariat of the "Barrier Free City Orienteering Competition 2018" (The Secretariat) respects your privacy and commits ourselves to protecting the personal data we collect from you. We will apply and comply with the laws and principles of the Personal Data (Privacy) Ordinance (Cap 486) (PDPO) of the Laws of Hong Kong in collecting, holding, processing and using your personal data.

#### Privacy Policy

- ◎ The Secretariat collects personal information when you register as a Volunteer of Barrier Free City Orienteering Competition 2017. The Secretariat ask for your personal information such as your name, HKID / Passport, email address, birth date, gender, phone / fax number, address, any shot taking in the program and etc. Such personal information will be collected, stored and used for authentication purpose during registration, or when you utilize our service.
- ◎ The Secretariat will also collect, store and use such personal information for the following general purposes : to customize activitie(s), program(s), scheme(s), course(s), group(s) or volunteer service(s), improve our services, contact you, and conduct research, etc.
- ◎ All the information from the shot taking (e.g. : Photos, Video, and etc.) in the activatives, the Secretariat may edit and publish the information (including : portraits) in various media (e.g. : Radio, Print [e.g. : Books, Magazines, Newspapers, and etc.], computer media (e.g. : Websites, Facebook, Computer Programs, Mobile Programs), and etc.), without any notice or consent.
- ◎ The Secretariat may further use such personal information and/or provide such personal information to another person (including agent, contractor or third party service provider who provides administrative, telecommunications and computer service to 「Hong Kong PHAB Association」(HKPHAB), 「Information Technology Volunteer Services Association」(ITV) and Ants in connection with the operation of its business) for direct marketing / general promotions purpose in relation to business, or HKPHAB, ITV and Ants agents, sponsors, authorized related parties, companies and organizations connected with any other events promotions, but the Secretariat may not do so unless your written consent to such use and provision is received.

#### Security Practices

Once the Secretariat has obtained your personal data, they will be maintained securely in our system. Only the authorized workers will be permitted to access to such personal data. The Secretariat will also ensure compliance by our workers with the strictest standards of security and confidentiality.
